

Christmas Market at the Fair

RULES OF PARTICIPATION IN **THE CHRISTMAS MARKET**
ORGANIZED BY THE INTERNATIONAL POZNAŃ FAIR SP. Z O. O.
ON 16.11-22.12.2024

§ 1 General information

1. The organizer of the Christmas Fair at the Fair is Międzynarodowe Targi Poznańskie sp. z o.o. with its registered office in Poznań at ul. Głogowska 14, 60-734 Poznań, entered into the National Court Register - District Court Poznań - Nowe Miasto i Wilda in Poznań, 8th Commercial Division of the National Court Register, under KRS number 0000202703, with the share capital of PLN 400,312,000.00 and the register of active VAT payers - NIP 7770000488, hereinafter referred to as the **Organizer**.
2. The Christmas Market (hereinafter also referred to as: Market) will take place in Poznań on the premises of the Poznań International Fair at the Universal National Exhibition Square (Place Pewuka; entrance from ul. Głogowska). The area of the Christmas Market has been marked on the map attached to the regulations.
3. The Market is open to participants from 16/11/2023 to 22/12/2024, from Tuesday to Sunday, from 11:00 a.m. to 9:00 p.m.
4. The Market is a commercial event. Some attractions may be of a cultural nature. During the fair, the rules of the area and these rules are in force and are available at the event venue.
5. These regulations apply to all participants – persons using the offer (hereinafter referred to as **Participants**), exhibitors and entities organising attractions (hereinafter referred to as **Exhibitors**) during the Christmas Market

§ 2 Participants

1. The Market is free of charge for Participants, with the reservation, however, that the use of Exhibitors' offers may be subject to a fee.
2. The Participant may use the attractions offered at the Fair, such as:
 - a. ice rink,
 - b. mill wheel,
 - c. carousel,
 - d. catering services.

Detailed information on the operation of the above-mentioned attractions, including opening hours, ticket prices, regulations for using the given attraction, are available on the website: <http://jarmark.poznan.pl/> and on the Market fairgrounds.

3. Children under 13 years of age must be under adult supervision at the Market.

§ 3 Exhibitors

1. Persons and entities interested in offering their services, selling goods or organizing attractions during the Fair should direct their enquiries directly to the Organizer at the following address: info@grupamtp.pl.
2. Participation as an Exhibitor may involve fees. Detailed conditions for participation as an Exhibitor are agreed directly with the Organizer.
3. The Exhibitor is obliged to take care of the Organizer's property, in particular to protect the rented space from dirt, not to interfere with the Organizer's infrastructure, and to comply with the guidelines of the Organizer and security services..
4. Exhibitors are obliged to comply with the ban on selling alcohol to minors or intoxicated persons.

§ 4 Order regulations

1. At the Market it is prohibited to:
 - a. bringing, possessing and using weapons, ammunition or pyrotechnic materials or harmful chemical substances, as well as open fires that constitute a fire hazard, a threat to property or pose a threat to the health and life of persons, narcotics or psychoactive substances,
 - b. use of unmanned aerial vehicles (e.g. drones) without the express written consent of the Organizer,
 - c. polluting the space with any waste,
 - d. destruction of any elements of spatial infrastructure, including vegetation, as well as use of this infrastructure in a manner inconsistent with its intended purpose.
2. The organizer allows dogs to be brought into the Market, with the exception of dogs of breeds considered aggressive in accordance with the regulation of the Minister of Internal Affairs and Administration on the list of dogs considered aggressive (Journal of Laws of 2003, No. 77, item 687, as amended) and provided that the dog remains on a leash and under the control of the dog's owner. The dog's owner is obliged to remove all waste generated by the animal and throw it into containers for mixed waste.
3. The Organizer asks that the welfare of animals brought to the Market be considered, in particular taking into account any attractions organised at a given time at the Market, as well as the number of people present at the Market.

4. In the event of failure to comply with the restrictions, orders or prohibitions in force at the Fair, the person committing such a violation may be immediately removed from the Market, and re-entry to the Market may be prevented. In justified cases, the Organizer reserves the right to call (notify) the appropriate services, including the Police.
5. The Market area is monitored.

§ 5 Image

Each Participant and Exhibitor agrees to the free use by the Organizer of their image recorded as part of photographic or audio-visual documentation during the Fair. The consent includes:

- a) recording and reproducing by any known technique and distributing (making public) in any form,
- b) entering into computer memory and a multimedia network,
- c) reproducing the recording of the recorded image,
- d) public display, display, reproduction, and making available to the public in such a way that everyone can have access to it at a place and time of their choosing,
- e) posting and publishing in the press, on websites, in social media (in particular on Facebook, Instagram, YouTube, LinkedIn).

§ 6 Final provisions

1. The Regulations are effective from 16.11.2024.
2. Participation in the Fair is tantamount to acceptance of the provisions of these Regulations.
3. In matters not regulated in these Regulations, the provisions of generally applicable Polish law shall apply.
4. Any disputes arising from or related to these Regulations shall be resolved by a common court with jurisdiction over the seat of the Organizer.
